The Foreign Service Institute (FSI) of the Ministry of External Affairs in New Delhi is organizing the 11th Special Course for ASEAN Diplomats from August 9-September 8, 2017.

2. In this context, Quotations with taxes break up are invited for booking 20 single rooms for 3 nights from August 31-September 02, 2017 in Bengaluru as per the following conditions:

i) Quotation should be included room charges + taxes + rates of all three meals+ taxes.
ii) The diplomats should be provided with newspaper and complimentary internet services in the room

iii) Any expenditure on laundry, telephone calls, consumption of soft drinks/juice, bottled mineral water, liquor, min I bar usage, car/taxi hire which are not part of the guest facility and are chargeable by the hotel, would be paid by the guest themselves. However, FSI would have no objection on the hotel offering any of these services on complimentary basis.

iv) The guests should be received at the airport on arrival and seen off at the time of departure (airport pick-up and drop-off) – rates to be quoted separately;

v) The charges for hiring a Volvo or 25-seater A/C bus for internal travel of the guests may also be separately quoted;

vi) Any other complimentary facility, which the hotel desires to provide, may be specified.

vii) A broad guideline describing the admissible and non-admissible items should be handed over to each diplomat on arrival and a copy of the same should also be placed at every room. A copy of the same should be mailed to the undersigned in advance for approval;

viii) The hotel must be a five star deluxe property. Proof of the same would be required to be submitted along with the quote.

4. Since these diplomats would be guests of Government of India, a certificate to that effect would be provided for waiver of taxes as per statutory provisions.

5. Last date and time of submission of quotations - 28th August, 2017, Monday by 1000 hrs.
